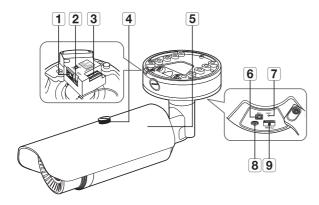

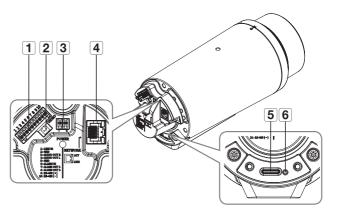

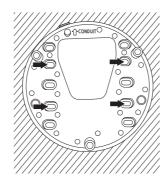

Installation

1. Use the four tapping screws provided to secure the base wall mount.



- 2. Hang the safety cable up on a hook that looks like an arrow in the Bottom cover.
- 3. Connect the appropriate cables with camera terminals.
- 4. After placing the bottom cover on the base wall mount, use the L wrench provided to connect and secure the three screws.
- 5. After placing the camera on the bottom cover, use the L wrench provided to connect the three screws on the top cover.



- 6. Adjust the camera direction using the L wrench provided.
- When you adjust the camera position using a bracket, please loosen the bracket screw, adjust the camera, and tighten it. If you attempt to adjust it forcibly while the screw is tight, it may result in a scratch or other problems.

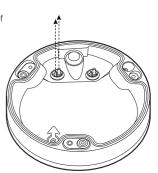


Connecting waterproof power cable and LAN cable

1. Pick off the extruded part of the rubber cover on the bottom side of the bottom cover as shown in the figure below.



- Use an appropriate cable bush for the LAN cable to be connected.
 - Basic camera: Use the cable with a diameter of Ø5~6.5.
- Components provided : Use the cable with a diameter of Ø7~8.5.



- 2. Insert the power cable into the small hole made by removing the projected part of the rubber plug in step 1 above.
- 3. Connect the power cable with the power terminal block.



- 4. Insert the LAN cable into the large hole made by removing the projected part of the rubber plug in step 1 above.
- 5. Remove the sheath with a cable cutter, and align the cables.
- 6. Connect the LAN cable with a LAN connector, and insert it into the I AN tool
- 7. Connect the finished cable to the Ethernet port.



Connecting the alarm and audio cable

1. Remove the rubber cover on the bottom side of the bottom cover as shown in the figure below.



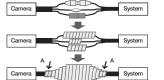
- 2. Insert the alarm/audio cable through the hole created by removing the rubber cap in No. 1, and connect the cable to the alarm terminal.
- 3. Align the cable so that it should not be damaged or jammed when installing the camera.
- 4. Put the rubber cap located on the alarm/audio cable in the hole.



Outdoor installation

When you install it outside of the building, please waterproof it with waterproof butyl rubber tape (can be purchased in stores) so that water does not leak from the gap of the cable connected to the outside.

- 1. Connect to cables, such as I/O and audio.
- 2. Wrap the black cable jacket (Area A) and the cable connection area with waterproof (butyl rubber) tape so that more than half of the butyl rubber tape is overlapped.



- If the cable jacket is not waterproofed properly, then it can directly cause leakage. Make sure to protect the cable with a dense layer of taping.
 - Waterproof butyl tape is made of butyl rubber that can be stretched to twice its normal length.

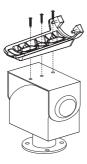

- 4. Insert the LAN cable into the right hole made by removing the projected part of the rubber plug in step 1
- 5. Remove the sheath with a cable cutter, and align the cables.
- 6. Connect the LAN cable with a LAN connector, and insert it into the LAN tool.
- 7. Connect the finished cable to the Ethernet port.
- 8. Insert the terminal block cable into the left hole made by removing the projected part of the rubber plug in step 1 above.

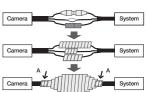
Outdoor installation

When you install it outside of the building, please waterproof it with waterproof butyl rubber tape (can be purchased in stores) so that water does not leak from the gap of the cable connected to the outside.

- 1. Connect to cables, such as I/O and audio.
- 2. Wrap the black cable jacket (Area A) and the cable connection area with waterproof (butyl rubber) tape so that more than half of the butyl rubber tape is overlapped.



- If the cable jacket is not waterproofed properly, then it can directly cause leakage. Make sure to protect the cable with a dense layer of taping.

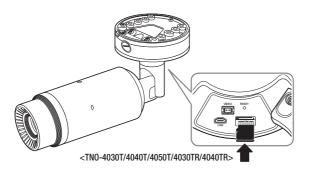


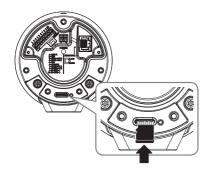
INSERTING/REMOVING A MICRO SD MEMORY CARD

- Disconnect the power cable from the camera before inserting the Micro SD memory card.
- Do not insert the Micro SD memory card while it's upside down by force. Otherwise, it may damage the Micro SD memory card.
- When it rains or the humidity is high, insertion or ejection of a Micro SD card is not recommended.

Insert a Micro SD card in the arrow direction shown in the figure.

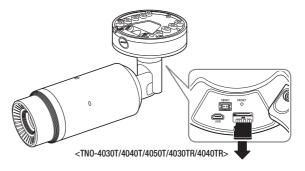


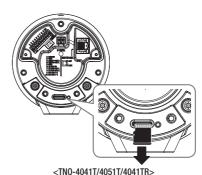

Removing a Micro SD Memory Card

Gently press down on the exposed end of the memory card as shown in the diagram to eject the memory card from the slot.





- Pressing too hard on the Micro SD memory card can cause the card to shoot out uncontrollably from the slot when released.
- Before removing the Micro SD memory card, in **<Storage>**, set the device to **<Off>** and press the [**Apply**] button and turn
- If you turn off the camera or remove the Micro SD memory card that contains data from the product, the data may be lost or damaged.

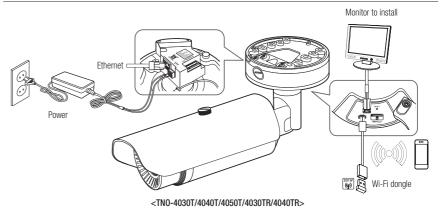

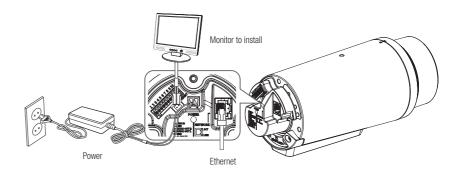

- The Micro USB out terminal of the product is provided for easier installation, and is not recommended for monitoring purposes
- If the screen freezes for about 1-2 seconds at a certain time interval or when there is a change in the temperature of the surrounding area, this is normal; the screen is simply undergoing a calibration process.

Ethernet Connection

Connect the Ethernet cable to the local network or to the Internet.

Camera Setup

1. Connect OTG adapter (5-pin) and WiFi dongle to the micro USB terminal.

Smartphone Setup

- 1. Install the Wisenet Installation application.
- 2. Select the camera SSID after turning on the WiFi.
- 3. Run the Wisenet Installation application.
- 4. When you log in to the camera, the video will be connected. (initial password: 4321)
 The video will be played without being logged in during the initial connection.
- 5. You can adjust angle of view while watching the video through smartphone.

Power Supply

Use the screwdriver to connect each line (+, -) of the power cable to the corresponding power port of the camera.



- When supplying PoE and DC 12V or PoE and AC 24V power at the same time, the equipment is powered by the external source (AC 24V, DC 12V).
 - You can also use a router featuring PoE to supply power to the camera.
 - Use PoE that is compliant with the IEEE 802.3af protocols.
 - It is recommended to use a single source for powering the equipment among PoE, DC 12V and AC 24V.
- Be careful not to reverse the polarity when you connect the power cable.
- When the power is initially turned on, time is needed to allow the screen to stabilize. For this reason, a screen calibration is performed when the power is initially turned on.
- If you want to connect an external device, you must turn off the external device before proceeding.
- Connect the set and the adapter power line first, and then connect the power cable to the outlet on the wall.

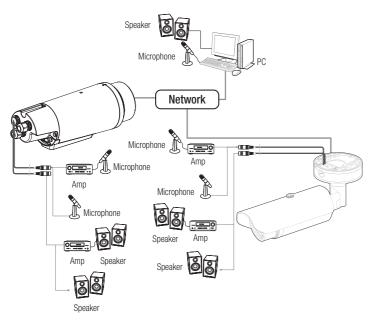

Alarm Out Wiring Diagram

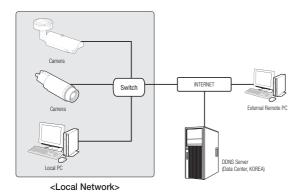

Once you register a dynamic IP-based device with the DDNS server, you can easily check the changed IP when you try to access the device.
